

Building Certifier licence

Levels of licensing - Section 151 of the Building Act 1975 (the Act)

Building Certifier - Level 1 - section 152 of the Act - may perform building certifying functions for all classes of buildings and structures.

Building Certifier - Level 2 - section 153 of the Act - may only:

- a. without the supervision of a building certifier level 1 perform building certifying functions on buildings and structures having a rise of no more than 3 storeys and a total floor area no more than 2000m²; or
- b. under the supervision of a building certifier level 1 help in assessing and inspecting all classes of buildings and structures.

Building Certifier - Level 3 - section 154 of the Act - may only perform building certifying functions on class 1 buildings or class 10 buildings or structures.

Where an applicant seeks endorsement as a Private Certifier (class A and B) the following information is required:

- Evidence the applicant holds Professional Indemnity Insurance as prescribed by the Building Regulation 2006.
- A private certifier class 'B' may apply for endorsement to issue development permits under section 160 of the Act to become a class 'A' private certifier.

Where an applicant seeks development approval endorsement:

• Evidence that the applicant has completed the course called "Issuing Development Permits for Building Work" as perscribed by the *Building Regulation 2006*, section 52(4).

Change in level of licence

This application form may also be used by a person holding an existing building certifiers licence who wishes to change the level of the licence to a different level. If an application for a change in level of licence is received and subsequently approved, the earlier licence will be cancelled and the original licence number reused. Generally, these applications must be accompanied by the full application and licence fees. However, discretion may be exercised to allow a waiver of part payment of the annual licence fee based on a pro-rata allowance for any remaining period on the cancelled licence. Please discuss this matter with the QBCC at the time of application.

Professional indemnity insurance requirements - Section 52 of the *Building Regulation 2006*A building certifier seeking endorsement as a private certifier must have professional indemnity insurance including confirmation that non-compliant building products are not excluded from cover that provides:

(a) A minimum limit of indemnity of \$1 million for any claim and in the aggregate during any one (1) period of insurance that may arise from the performance of private certifying functions;	(b) In addition to the limit of indemnity mentioned in (a) - indemnity for costs and expenses incurred with the consent of theinsurer of defending or settling a claim;
(c) Indemnity for breaches of professional duty as a private certifier arising from an act, error or omission of the private certifier after the day the private certifier was first accredited as a private certifier;	(d) If the private certifying functions are performed as an employee - indemnity to former principals, partners and directors or the employer who were, but are no longer, private certifiers.
(e) Indemnity for negligent performance of a building certifying function;	(f) At least one (1) automatic reinstatement of indemnity.

Other conditions may also apply and applicants should check section 52 of the *Building Regulation 2006*, for full details. The professional indemnity insurance must include all conditions required by the Regulation.

One particular provision allows a private certifier, who is a member or employee of a corporation or other entity, to fulfil this condition if the corporation or other entity has the required professional indemnity insurance policy. In this case, the member or employee must provide evidence of the relationship that exists with the corporation or other entity and a certified copy of their professional indemnity insurance.

Privacy Policy

The Queensland Building and Construction Commission manages personal information in line with the *Information Privacy Act 2009*.

This Privacy Policy describes the personal information that may be collected and used by the QBCC. We collect and manage your personal information from you when you:

- complete and submit a form electronically or by mail
- you deal with us over the telephone or counter
- you register for My QBCC
- email us
- provide us with feedback

ask us to contact you, and you consent to us collecting, storing, using, maintaining and disclosing your personal information.

Information we may request

We may ask you to provide personal information if you submit feedback to QBCC or lodge a form, electronically or otherwise.

We will only do this:

- to meet your needs (e.g. answer a question)
- to meet our needs (e.g. demographic analysis, updating our records)
- if required by law.

'Personal information' includes your name, address, phone number, email address, age, gender, your employer.

Use of personal information

Depending upon the type of enquiry, application or form you have submitted. If you're a QBCC licensee, your personal details may be used to send you important updates regarding new legislation or amendments, changes to policies and other such information related or connected to your licence.

Marketing

Disclosure of personal information

If you have submitted an application or complaint, we may

- external legal consultants
- external financial consultants
- reinsurers/actuaries.

We may also disclose your personal information to third parties, including advisors and consultants and with third party service providers we use in connection with conducting our business and always subject to confidentiality provisions we deem appropriate.

Some of the third parties to whom we disclose your personal information may be located outside Australia. For example, we may disclose your personal information to external facilities in the course of data processing services from third parties.

The countries in which these third parties are located will depend on the circumstances. However, in the course of our ordinary business operations we commonly disclose personal information to third parties located in the United States of America.

We will not give your personal information to third parties without your consent, unless as set out above or required by law.

Access to personal information

If you would like to access any of your personal information that is held by QBCC you can make an Information Privacy application.

Amending your personal information

You may apply to amend documents containing your personal information held by QBCC, where you believe relevant information is inaccurate, misleading, out of date or incomplete.

Making a privacy complaint

If you believe there has been a breach of your personal information involving QBCC you may lodge a privacy complaint.

Right to information

All information held by the QBCC may be subject to application for access under the *Right to Information Act* 2009 (RTI Act).
