

s97C(5) TEMPLATE PAYMENT WITHHOLDING REQUEST

NOTICE OF PAYMENT OR EXPIRY

INFORMATION ABOUT THIS TEMPLATE

Section 97C(5) of the *Building Industry Fairness* (Security of Payment) Act 2017 (BIF Act) provides that a claimant that has been paid the unpaid adjudicated amount must inform the higher party who has been given a payment withholding request of payment within five (5) business days after the amount is paid.

Failure to do so is an offence and may incur a penalty.

NOTE: notification to the higher party of payment is required for both a **full or part** payment of the adjudicated amount.

Section 97G(3) of the (BIF Act) provides that a charge over an amount withheld expires if:

- the respondent pays the unpaid adjudicated amount to the claimant
- an adjudication decision relating to the amount is set aside and the respondent pays into court, as security, the unpaid portion of the amount pending a final decision; or
- the adjudication certificate relating to the amount is filed in court as a judgment for debt, but the court dismisses the proceedings for enforcement.

COMPLETING AND GIVING A NOTICE OF PAYMENT OR EXPIRY

This template is to be completed by the claimant and given to the higher party to advise that all or part of the unpaid adjudicated amount the subject of the payment withholding request has been paid. It may also be used to notify the higher party that a charge over an amount withheld has expired.

The obligation for the higher party to retain the amount stated in the payment withholding request ends when the claimant is paid the adjudicated amount in full. A part payment of the adjudicated amount removes the obligation only to the extent of the part payment.
