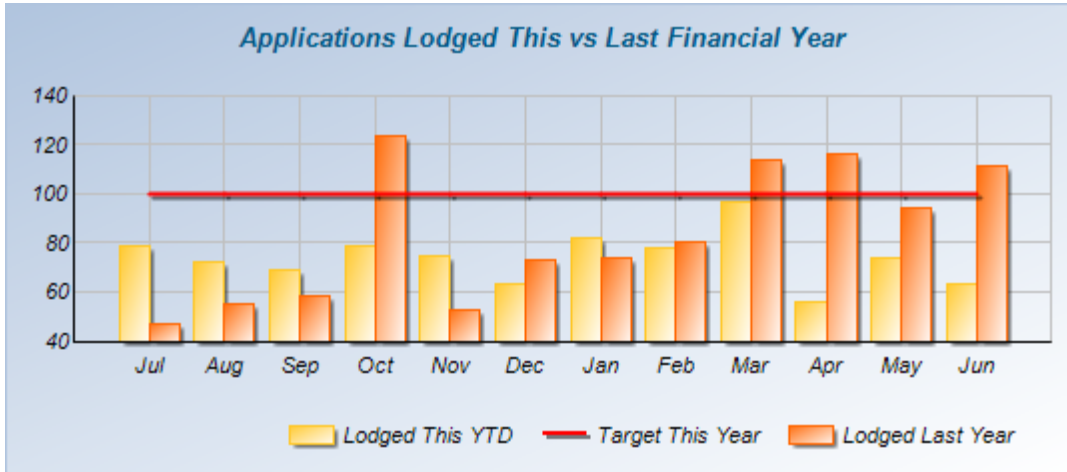

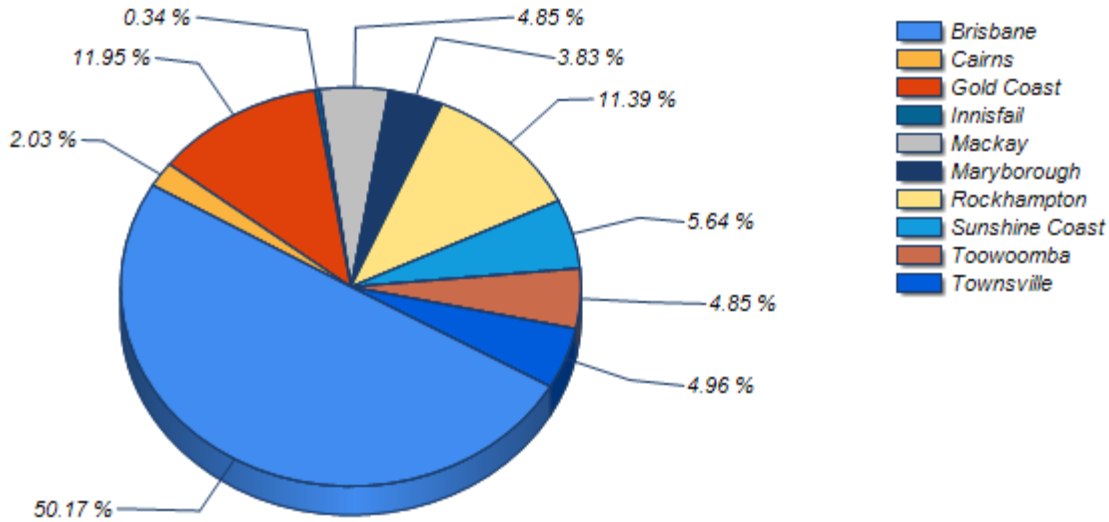

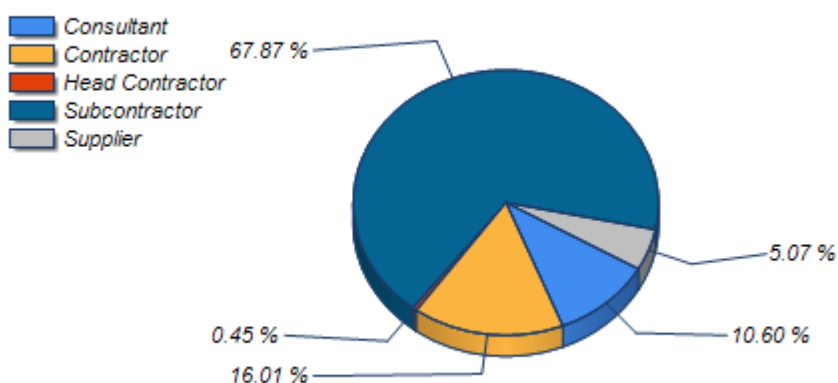

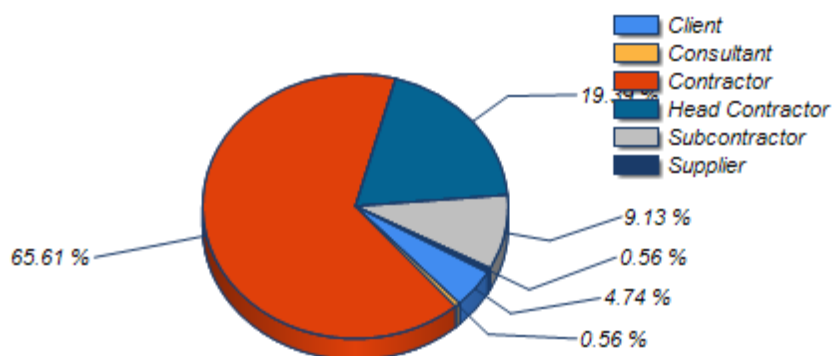

% Respondent Type YTD

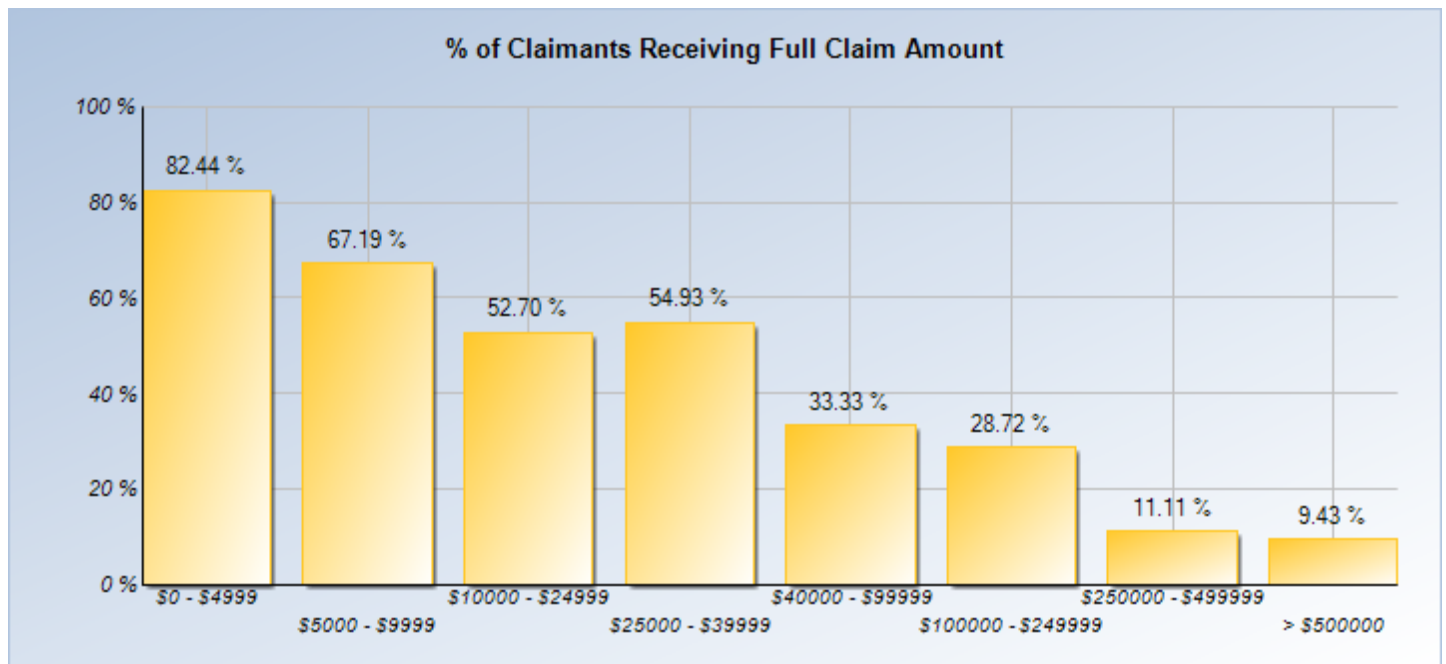

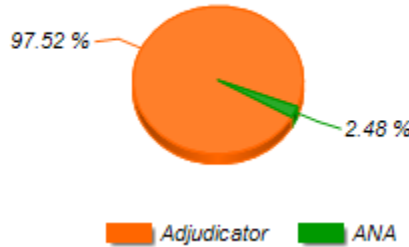

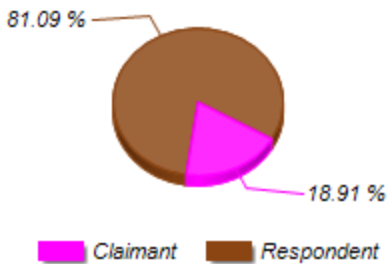

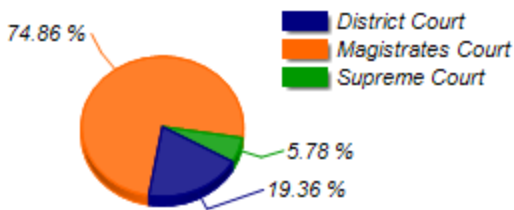
% Fees Paid Claimant vs Respondent
