

INFORMATION FOR APPLICANTS

The following information provides assistance for Applicants applying to be registered by the Adjudication Registrar, as an Adjudicator under section 159 of the *Building Industry Fairness* (Security of Payment) Act 2017 (the Act).

You will need to supply the following:

- A certified copy of driver's licence or passport.
- 3 referees who can attest to your experience which is relevant to deciding adjudication applications.
- Certified copies of all qualifications listed in the application.

Under Section 159(2) of the Act, this application form must be signed by or for the Applicant; and be accompanied by the fee of \$796.80 as prescribed under the *Building Industry Fairness (Security of Payment) Regulation 2018*.

IF APPLICATION IS ACCEPTED

- Registration will become effective in accordance with Section 164 of the Act.
- It is a condition of registration that Adjudicator's comply with the Act and any other conditions of
- registration imposed under Section 165 of the Act.
- Continued registration is dependent on such compliance.
- Under Section 170 of the Act, a registrant who contravenes a condition of registration is liable to have their registration suspended or cancelled

Collection of this information is authorised by the *Building Industry Fairness (Security of Payment) Act 2017*.
