

Public-facing conflict of interest register

The QBC Board is committed to supporting transparency, accountability and integrity to protect the public interest.

QBC Board members have a duty to identify and internally disclose actual, perceived or potential conflict(s) of interest. The QBCC and the Board actively manage identified conflicts in accordance with internal policy to ensure decisions are made in an unbiased and fair way. This includes strategies such as redacting board material and board members leaving the room when conflicts arise, so they are not included in the discussion and decision-making process.

This 'Public-facing Conflict of Interest Register' is published with consent of the Board members. It is a live document, and it will be updated as new conflicts arise or as conflicts are closed and reviewed on a 6-monthly basis.
