- In addition to the limit of indemnity mentioned in (a) - indemnity for costs and expenses incurred with the consent of the insurer of defending or settling a claim;
- Indemnity for breaches of professional duty as a private certifier arising from an act, error or omission of the private certifier after the day the certifier first became a private certifier;
- At least one (1) automatic reinstatement of indemnity;
- Indemnity for negligent performance of a building certifying function (other than for claims for fraudulent or illegal acts or omissions);
- If the private certifying functions are performed as an employee - indemnity to former principals, partners and directors of the employer who were, but are no longer, private certifiers.

And provides cover for the following building certifier/s of this company/business as set out in schedule A.

Note: External cladding insurance changes now until 30 June 2023

The previous professional indemnity exemption timeframe has now been extended. Until 30 June 2023, private certifiers may have an exclusion in their professional indemnity insurance coverage for performing private certifying functions directly related to external cladding, or the use of external cladding, that does not comply with any of the following:

- an Act or other law of the Commonwealth or a State;
- an Australian Standard;
- the Building Code of Australia.
