Fee for an approval of a pool safety management plan for a swimming pool (Act, s245M(2)(b)(ii))

(a) If a pool safety management plan has not previously been approved for the pool:

i. Standard fee	\$2,366.98
ii. Additional fee if the pool safety management plan relates to more than 1 swimming pool	\$132.71 for each additional pool
iii. Additional fee if a site inspection by the QBCC Commissioner is required for the pool	\$1,330.51

(b) If a pool safety management plan has previously been approved for the pool:

i. Standard fee if pool safety measures under the pool safety management plan are the same, or substantially the same, as the pool safety measures under the previously approved plan	\$473.98
ii. Standard fee if subparagraph (i) does not apply	\$2,366.98
iii. Additional fee if a site inspection by the QBCC Commissioner is required for the pool	\$1,330.51
