The QBCC is collecting personal information on this form to determine whether you are entitled to renew your licence, and if so, to maintain your licence. This is authorised by the *Plumbing and Drainage Act 2018*. The QBCC will not be able to process the application if all or some of the information is not provided.

We may also use your email address to contact you about research and engagement activities for the purpose of improving our services (which you will be able to opt-out of receiving), as well as educational activities.

The QBCC will update your licence information in our online registers, including the Plumbing and Drainage Licensee Register on the QBCC website (<a href="https://docs.pud-search">docs.pud-search</a>). The QBCC may also provide updated licensing information to other interstate or New Zealand licensing bodies. Your personal information will only otherwise be disclosed with your consent or as required or authorised by law.

- You cannot apply to renew a provisional licence. You must apply for a full occupational licence or, if you have not completed 12
  months' licensed experience, you will need to apply for another provisional licence.
- It is your responsibility to ensure that your licence is current and that you apply to the QBCC to renew your licence on or before the expiry date.
- Your licence must be current to carry out plumbing or drainage work.
- · If you do not apply to QBCC to renew your licence on or before the expiry date, your licence will automatically expire.
- You can apply to restore an expired licence within one year after the day the licence expired. If you wait longer than one year, you will need to make a new licence application and meet the technical requirements in place at that time.

### **6. LICENCE RENEWAL FEE PAYMENT**

**Pay in person** – visit a QBCC Customer Service Centre and use either bank keycard, Mastercard or Visa card to make a payment at the front counter.

Pay by mail - if you are posting your notice to us, you must complete the credit card details section below.

**Pay using BPAY** – you will receive a renewal notice in the post and by email prior to your licence expiry date that contains the BPAY Biller code and your Reference number.

NOTE: QBCC does not accept payment by cash or cheque.






**PLEASE NOTE:** Any passport-size photos you provide may be used on other QBCC licences you hold, and you may be required to provide photos for other licences in the future.

- Using a paper clip, attach the signed photos to this form in the space provided above. DO NOT STAPLE PHOTOS TO THIS FORM.



### **ASSOCIATED QBCC ACT LICENCES**
