The QBCC will update your licence information in our online registers, including the Pool Safety Inspector register on the QBCC website (dbcc.build/psi-search). Details regarding the surrender of your licence will also be shared with interstate or New Zealand licensing bodies. The QBCC will not otherwise disclose your personal information without your consent, or as required or authorised by law.

IMPORTANT - WHEN TO USE THIS FORM

- If you surrender (cancel) your licence now and then decide to reapply for a licence at a later date, you will need to submit a new application form, pay the relevant fee and meet all licensing entry criteria current at that time, including the technical qualification.

 Your current technical qualification may not be sufficient.
- As part of the process of surrendering your licence, you are required to **return your licence card to QBCC within 10 business days** of the date of surrender. Failure to do so may result in a fine.
- If your licence card has been **lost, stolen or destroyed,** you must **complete the statutory declaration** included on page 2 of this form and have it witnessed by an appropriate witness.
